Duane Cunningham gave a brief update on the VHA regarding COVID-19, Flu Clinics, billing, shipping of medications, and the Mission Act.

Staffing Changes

Administrator Ackerman

The Veteran Service Program Manager, Cheryl Heald, retired in July 2020 after thirty years in the agency. The Western Regional Veteran Service Officer, Ryan Keeler, replaced her in July 2020. Ryan works in the Kalispell office and is a retired US Marine. MVAD has not replaced the full time Veteran Service Officer in Billings.

The Cemetery Program is currently fully staffed but will have a position open starting September 30th, 2020. The Cemetery Program Manager, Curt Aasved, is retiring after fourteen years in the division. The Cemetery Program Manager position has been advertised and interviews will be held early October. The position can be filled at any three of the cemeteries.

Vacancies in the division include a Veteran Service Office in Helena and Billings. The Governor's office has advised all state agencies to hold off recruiting. MVAD will not be filling positions until Leaislature comes down with next biennial budget.

In 2019, there was a grievance filed against MVAD leadership and that grievance has been resolved with no cause.

2021 Legislative Update

MVAD submitted two proposals for the next legislative session. One proposal which was accepted is to increase the percent of license plate revenue to the cemetery program by reducing the revenue going to VA services. The second proposal was submitted and denied by the Governor's office. The proposal was for the Patriot License Plate fee to increase from \$15 to \$20. The Governor's office denied the proposal not wanting to burden the taxpayers with an increased fee during a pandemic. MVAD is hoping for a legislator to review the proposal and carry it. Gary Swartz asked what the Patriotic License Plate looked like and who can purchase them. Kelly explained that the Patriotic License Plate is for civilians, and Taryn Phillips presented a picture of the license plate.

Gary Swartz asked if Montana has proposed to have military retirement exempt from taxes. Gary White explained for the past nine legislative sessions, the American Legion has fought to pass military retirement being exempt from state taxes. The 2019 session proposed for a 50% tax exemption, it moved through the committee, but was short two votes to pass. The American Legion plans on proposing it again this session.

Biennial Report

Casey McInerney reviewed the Biennial Report provided in the board meeting packet. Casey asked if there were any questions. Administrator Ackerman mentioned Casey and Taryn built a new format for the Biennial Report and this format will be used from now on. Administrator

Ackerman reviewed the financial impact in fiscal year 2020. Administrator Ackerman then reviewed the statistics of burials and gave an update to the COVID-19 procedures of burials. The VA expansion grant for the Eastern Montana State Veterans Cemetery will be finished October 1st, 2020.

Budget Analyst, Casey McInerney, reviewed MVAD budget for fiscal year 2020 (July 2019-June 2020) and 2021 (July 2020-June 2021). MVAD is on track this FY with a healthy budget. There was a large payout to Cheryl Heald when she retired at the beginning of fiscal year 2021. Looking at fiscal year 2020, the Honor and Remember Medallion Fund was not utilized. It was decided to produce advertising materials. After research, it will be cheaper for MVAD to design, print and distribute advertising materials rather than using a third-party. Taryn Phillips presented the advertising materials developed on the projector.

The **Veteran** license plate costs \$10 annually, and its statewide sales are earmarked to maintain and operate our state veteran's cemetery program. There are three veterans' cemeteries: Fort Harrison (near Helena), Miles City and Missoula.

The **Patriot** vehicle license plate is available to all licensed drivers, and costs \$15 annually. The proceeds help fund our veterans' services program, which includes all our statewide service offices.

Who is eligible for burial?

All veterans who serve at least 90 days of active duty and were released from the Armed Forces under honorable conditions. National Guardsman or Reservist are eligible with a 20 Year Letter or members that were ordered to Active Duty and a DD 214 was issued. Both the veteran and their spouses are eligible for burial.

What if the spouse of a veteran expires first?

The spouse of a qualifying veteran can be buried first at the State Veteran's Cemetery.

What are the requirements and costs involved?

Requirements for both the Veteran and Spouse are the Veteran's Honorable Discharge papers (DD-214 or equivalent), copy of the Death Certificate and a copy of the Burial Transit Permit or Cremation Certificate.

Veteran Fees

- Headstone Setting Fee
- Cremation Vault for in ground

Spouse Fees

- Opening and Closing Fee
- Headstone Setting Fee
- Cremation Vault for in ground

Call your desired cemetery for current pricing.

Can I reserve a space before my death?

No. Burials are conducted in the order they come into the cemetery. However, veterans and spouses can pre-register for interment. Contact the cemetery to get a Pre-Registration Application.

What type of burials are provided at the cemeteries?

Full-size (casket) burials and cremated remain burials at the cemeteries.

There are two options for the placement of cremated remains at the cemeteries.

- Above-ground columbarium niches for cremated remains.
- In-ground burial of cremated remains.

The choice for the placement of cremated remains will need to be determined by the next-of-kin.

How are committal services handled?

Cemeteries perform services from 9:00 a.m. – 3:30 p.m. Monday-Friday. No services are performed on federal holidays. All interments are made immediately after the committal service.

What is the standard procedure at the cemeteries?

- The cemetery will be open each day from 8:00 a.m. to sunset
- There are no animals authorized on cemetery grounds
- The consumption of alcoholic beverages or food is not allowed
- The planting of shrubs, trees, or flowers by the public is prohibited
- Statues, vigil lights, breakable objects of any nature, are not permitted on graves at anytime
- Floral items and other types of decorations may not be secured to headstones or markers
- Artificial flowers are allowed from November 16 through March 15 (to be removed at the discretion of cemetery personnel)
- Cut natural flowers placed on the grave are allowed at any time (to be removed at the discretion of cemetery personnel)
- All persons within the cemetery will conduct themselves in a manner befitting a sacred place

The 1991 Legislature enacted authority for issuance of veteran license plates. A motor vehicle owner and resident of Montana who is a veteran or the surviving spouse (who has not remarried) of a veteran of the Armed Services of the United States, may be issued veteran license plates. National Guard/Reserve retirement eligible and surviving spouse (who has not remarried) also may have veteran license plates.

Montana Codes Annotated 61-3-458

Eligible participants must submit official discharge papers (DD 214) or retirement documentation to local County Treasurer. In addition to regular fees, there is a \$10.00 plate fee for the original application and all renewals. The entire \$10.00 supports the State Veterans Cemetery Program.





What is an eligible service member?

An eligible service member is a member of the United States armed forces who:

- Was killed in action or classified by the United States as missing in action on or after September 8th, 1939 while:
- Engaged in an action against an enemy of the United States;
- Serving with friendly foreign forces engaged in an armed conflict in which the United States was not a belligerent party against an opposing armed force; or
- Engaged in military operations involving conflict with an opposing foreign force
- Was serving on federal military active duty orders
- Was a legal resident of Montana at the time

What are the qualified United States armed forces?

"United States armed forces" means the active and reserve components of the United States:

- ⋆ Army
- Marine Corps
- Navy
- ⋆ Air Force
- Coast Guard

Who is eligible to receive a medallion?

"Family member" means the spouse of an eligible service member or a person who is a:

- Parent
- ★ Child
- ⋆ Brother
- ⋆ Sister
- Grandparent

The family member can be by lineage, adoption, legal guardianship, or marriage.

How much does a Medallion cost?

Per state of Montana statutes, the <u>first</u> Honor and Remember Medallion issued to a deceased service-member's authorized family member is at **no cost.**

After the first medallion has been provided to a family member, additional family members of the eligible service member may purchase additional medallions for \$20.00 per medallion.








Annual Interment Trend






Current as of 21May2021
